## 7.1. Precautions for safe handling

Safe use of the product : The product must be handled in accordance with good industrial hygiene and safety

Ensure the complete gas system was (or is regularily) checked for leaks before use.

Do not smoke while handling product.

Use only properly specified equipment which is suitable for this product, its supply pressure and

temperature. Contact your gas supplier if in doubt. Use only oxygen approved lubricants and oxygen approved sealings.

Avoid suck back of water, acid and alkalis.
